Overview: Washburn Tech received grant funding from the Blanche Bryden Foundation to assist high school students who are eligible for free or reduced lunch at their home high school. To help as many students as possible, the scholarship is limited to \$150 per semester. (Funds awarded until depleted).

Eligibility requirements:

- Must be attending Washburn Tech as a high school student
Students who have attended Washburn Tech previously, must have an overall GPA of 2.5 or higher
Must be eligible for free or reduced textbooks at the school district
Must provide documentation from the high school for the 21-22 school year, regarding eligibility for free/reduced textbooks.

Documentation must be attached to the Scholarship Application when submitted to be considered complete.

Scholarship Awards: Awards are granted on a first-submitted, first-awarded basis to eligible students. If funds are available, applications are accepted throughout the semester.

This scholarship is not automatically renewable. However, recipients who continue to meet eligibility requirements, may request a renewal of funds for subsequent semesters within the same academic year by sending an email request to tech-fa-info@washburn.edu. The email must include the student's name, WIN, and program. If funds are available, renewal requests are granted in the order they are received.
