✓ Program Requirements	<ul> <li>Kansas Department of Aging and Disability Services (KDADS), regulations require students to have a social security card to be eligible to take the exam to become a certified Nurse Aide, Home Health Aide, and/or Medication Aide in the state of Kansas. Therefore, students enrolling at Washburn Tech in the Nurse Aide, Home Health Aide and/or Medication Aide course(s) <u>must present their social security card during the application process.</u></li> <li>Students are required to obtain a physical and TB test with the licensed health care provider of their choice (less than six (6) months old from the start date of the program).</li> <li>Students must also provide proof of their last Tetanus booster.</li> <li>Valid Health Insurance (MUST remain active during the entire program).</li> <li>Ability to regularly lift 50 or more pounds.</li> </ul>			
✓ UNIFORMS (REQUIRED)	<ul> <li>Students are required to purchase two (2) scrub tops in Caribbean blue and two (2) scrub bottoms in black for this program.</li> <li>Scrubs may be purchased from Similar Mode or from the vendor of the student's choice. Prices will vary by vendor. Similar Mode is located at: 915 SW 6<sup>th</sup> Ave. Topeka, KS 66606. The phone number is 785-235-0361.</li> <li>Tennis Shoes – preferred white shoes; if not white shoes they <u>must be clean</u>.</li> </ul>
