

## **Technical Standards**

## **DIESEL TECHNOLOGY**

The technical standards discussed in the following chart define performance expectations that must be met for advancement through and successful completion of the **Diesel Technology Program**. It is the policy of Washburn Tech to provide reasonable accommodations for those with disabilities, health impairments, and other disabling conditions. These standards can also be used to determine whether accommodations or modifications are necessary and have been established through consideration by faculty and consultation with the following sources: consultation with the advisory committee for the program, The Vocational Rehabilitation Act, The Americans with Disabilities Act, Dictionary of Occupational Titles, O\*Net Online developed for the U.S. Department of Labor.

The ability to choose the right mathematical methods or formulas to solve a problem.  The ability to shift back and forth between two or more activities or sources of information (such as speech, sounds, touch, or other sources).  The ability to time your movements or the movement of a piece of equipment in anticipation of changes in the speed and/or direction of a moving object or scene.  The ability to add, subtract, multiply, or divide quickly and correctly.

The ability to coordinate the movement of your arms, legs, and torso together when the whole body is in motion. The ability to make fast, simple, repeated movements of the fingers, hands, and wrists. The ability to quickly move the arms and The ability to exert muscle force repeatedly or continuously over time. This involves muscular endurance and resistance to muscle fatigue. The ability to exert yourself physically over long periods of time without getting winded or out of breath. The ability to lift 50 lbs of weight.
